Rebates will be administered by the CRA and calculated in May 2023. Restaurants must register for CRA Rebate by April 30, 2023 for the May 2023 rebate . Once registered, members do not need to reregister for the rebate. Offer valid through May 30, 2023 or until funds run out. Offer available for existing CRA members with current membership dues based on operation's gross revenue. Actual value of rebate will be determined and allocated based upon membership dues, registration in rebate program, and total number of rebate program registered members. Checks will be mailed within 45 days of calculation.
