Conditions that California has laid out for stay-at-home orders to end

Some communities have seen protests of stay-at-home orders, even as public health experts have warned that it's too early to reopen the state. Gov. Gavin Newsom's administration has laid out six key indicators that must be met before a lifting of statewide restrictions. Much of what's ahead though, will be decided by counties.
