

# U.S. pork producer to limit sales in California over new pig law

Seabord Foods, the nation's second-largest pork producer, says it will no longer sell certain "whole pork" products in California because of restrictions imposed by Proposition 12, which aims to place new regulations on animal confinement. The CRA and other major California business associations have filed a lawsuit, requesting producers be given more time to comply with the new law – state officials have not yet finalized regulations that will pave the way for compliance.
