Stay-at-home order for much of California extended amid COVID-19 overload at hospitals

As expected, the state has extended its regional stay-at-home order for the San Joaquin Valley and Southern California regions as hospitals try to treat an onslaught of COVID-19 patients. Officials extended the order without giving an end date or indication of how long the extension may last.

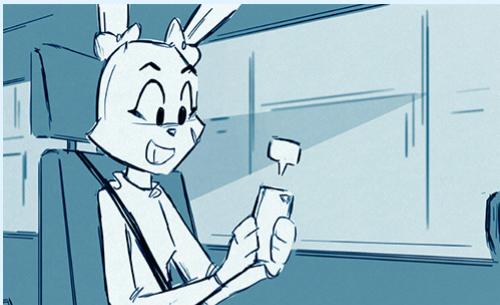

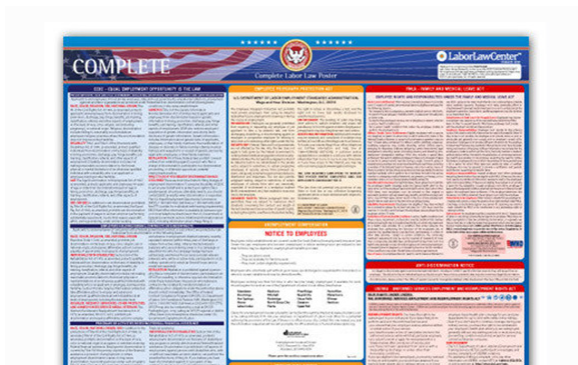

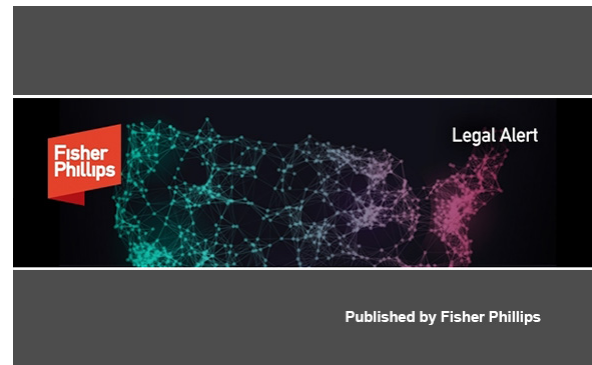
