## State opens the second round for California Small Business COVID-19 Relief Grant Program

Round 2 of the California Small Business COVID-19 Relief Grant Program opens today, February 2, 2021, and closes on February 8, 2021, at 6 p.m. The state maintains this is not a first-come-first served program. Selection notifications will take place between February 11-18, 2021. Round 2 is the final application window for the program. The amount of grant funding ranges from \$5,000 to \$25,000. Businesses are eligible based on their annual revenue as documented in their most recent tax return. If you submitted an application and the required paperwork during the first round and did not get approved, the state has indicated you do not need to re-apply and will instead be automatically considered for this next round.

## News You Need to Know: PPP and CA state taxes; restaurant workforce and vaccines

This week, Sabrina takes us through two critical issues: the Paycheck Protection Program (PPP) and vaccines. To help all California businesses, the CRA is helping to lead a coalition by asking lawmakers to pass State Assembly Bill 281. A.B. 281 will help to align state tax policy with federal law to ensure those businesses who've received PPP loans can deduct eligible expenses on their state taxes. The CRA has also been fighting to keep the restaurant workforce, who were deemed "essential" by the state to remain in Phase 1B, Tier 1.
