Judge halts California gig work law that threatened 70,000 truckers' jobs

A federal judge has blocked California's controversial gig-worker law, AB 5, from applying to tens of thousands of independent truckers, saying it is preempted by federal interstate commerce rules. The new law, which was aimed at making companies like Uber and Lyft classify independent contractors as employees is impacting people in other professions, who say they are harmed by it.

However, a 2015 study looked at a drive-thru ban in Los Angeles that took aim at obesity. According to the study, fast food consumption and obesity rates increased after the ban.


