News You Need to Know: Know the finalized Cal OSHA rules

After weeks of heated debate and an outcry from the CRA and the rest of the employer community, Cal OSHA has made several significant improvements to its new workplace mask rule, along with other rules that are part of the new Emergency Temporary Standard (ETS.) Don't forget — there is also a public-facing mask rule: unvaccinated guests should wear a mask on their way in and out of your restaurant. Legal Partner Content: Mask free for fully vaccinated California employees

On June 17, 2021, Cal OSHA approved the proposed revisions to its Emergency Temporary Standard (ETS,) meaning fully vaccinated employees no longer need to wear masks indoors, with limited exceptions during outbreaks and/or unless otherwise required by county, city, or business rules. The new rules also end social distancing except where an employer determines there is a hazard and for certain employees during major outbreaks. Exceptions may also apply per local or business rules. CRA legal partner Berliner Cohen provides insight on the approved revisions, plus action items for employers.
